REMOVAL OF GARBAGE CANS AND RECYCLING BINS

WHEREAS, the city of Gary has specified trash collection dates for each area of the city, with different days for different areas of the city; and,

WHEREAS, after trash has been collected, there is a need for the immediate return of the trash cans and recycle bins to be removed from the streets, sidewalks and alleyways to control clutter, blight and congestion, and,

WHEREAS, two days is a reasonable amount of time for trash to be placed off the common ways and in a location that does not have a negative impact on the character of a neighborhood, street or location.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Gary, Indiana as follows:

SECTION 1.

- (a) That within two (2) of trash collection day for a particular neighborhood, location or street, the person/entity having a possessory interest in property that utilizes garbage pick-up on a pre-set day every week shall insure that the garbage/recycling bin is removed from the street, sidewalk, alley, or any other location that is a nuisance or within the public way.
- (b) The penalty for failure to comply with section (a) as stated above shall be \$25 per day.
