**AN ORDINANCE APPROVING PAYMENT TO RACHELLE MORGAN CEASER
FOR MORE THAN ONE POSITION OF EMPLOYMENT**

WHEREAS, Ordinance No. 6315 was adopted on March 21, 1989 requiring common council approval for an employee of the Civil City of Gary, Indiana to receive salary for more than one position; and,

WHEREAS, Rachelle Morgan Ceaser is employed as the Executive Director of Constituent Services, and since April of 2023 has also been employed as the Superintendent of the Parks Department earning \$2,500 per pay period; and,

WHEREAS, it is in the best interest of the City of Gary to keep said employee in both positions until such time as the Superintendent of the Parks Department is back from maternity leave; and,

NOW THEREFORE, BE IT ORDAINED by the Common Council of the City of Gary, Indiana as follows:

That said employee receive salary from more than one position, specifically fund 258-1101 Support Services and fund 253-2204 Parks Department; and,

BE IT FURTHER RESOLVED, by the Gary Common Council that this ordinance apply retroactively to the date that said employee began to work in both positions and continue until such time as a Superintendent of Parks Department is back from maternity leave, scheduled for September 5, 2023.

This Ordinance shall be in effect after its passage by the Council in compliance with Gary Municipal Code § 2-397.
