## AN ORDINANCE FOR THE CITY OF GARY, LAKE COUNTY, INDIANA AUTHORIZING ADDITIONAL APPROPROPRIATIONS FOR THE AMERICAN RESCUE PLAN ACT FUND (FUND 2487) FOR THE GARY EASTSIDE COMMUNITY DEVELOPMENT CORPORATION WORKFORCE HOUSING
