AN ORDINANCE FOR THE CITY OF GARY, LAKE COUNTY, INDIANA AUTHORIZING ADDITIONAL APPROPROPRIATIONS FOR THE AMERICAN RESCUE PLAN ACT (FUND 2487) FOR AIR HANDLING AND VENTILATION SYSTEM AT CITY HALL UNDER REVENUE LOSS
