A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF GARY PROVIDING FOR A HEARING AND PUBLIC COMMENT ON THE TRANSFER/SALE OF CERTAIN PROPERTIES FORMERLY OWNED BY THE GUEA

WHEREAS, there is currently in effect an agreement between Gary Urban Enterprise Association, Inc. (GUEA), the City of Gary (City), Gary Redevelopment Commission (GRC) and the Office of the Indiana Attorney General (OAG); and

WHEREAS, prior to its dissolution, GUEA transferred certain parcels formerly owned by GUEA to the GRC for disposition according to law; and

WHEREAS, GRC and the Gary Housing Authority have agreed to transfer 548-54 Broadway (Parcel No.: 45-08-04-429-009.000-004) and 556-62 Broadway (Parcel No.: 45-08-04-429-010.000-004) formerly owned by GUEA and currently owned by GRC to the Gary Housing Authority; and

WHEREAS, the agreement for transfer/sale requires a meeting of the Gary Common Council to allow the public to make comments on the transfer/sale of the GUEA properties; and

WHEREAS, this process for disposition and sale of property for the Gary Redevelopment Commission is governed by Ind. Code 36-1-11-8; and

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Gary, Indiana that it has reviewed this resolution, held a public hearing allowed for public comment on the transfer/sale of the above referenced properties, and does not object to the transfer/sale.
