<u>REPORTS/QUESTIONS OF CITY OFFICIAL:</u>
Mayor Eddie Melton, City of Gary, presented the following announcement(s)/update(s):

- Mayor Melton along with the Chief of Staff, Chief of Police and the Director of Redevelopment met with Governor Eric Holcomb in Indianapolis, Indiana to discuss the issues and progress in the City of Gary.
- An update in public safety showed that the Gary Police Department had received 13,000 calls to date, averaging 200 calls per day and noting that there had been a significant drop in homicides compared to last year. Mayor Melton commended the Chief of Police and his staff as well as the Fire Chief and his staff along with the EMS workers for their dedication.
- Indiana Sugars in Gary, Indiana will be relocating to Buffington Harbor where they purchased the property and will build their new manufacturing plant and corporate headquarters. Mayor Melton stated that the City of Gary did not offer any tax abatements or any other resources.
- Expressions of appreciation were given to Atty. Carla Morgan (Corporation Counsel) and Michael Suggs (Chief Operating Officer) for taking the Westside Leadership Academy's women basketball team to Notre Dame for a tour of the campus and to experience the college environment.
- The City of Gary was awarded a grant for \$100,000.00 from the Legacy Foundation for a full-time grant 5) writer for the City of Gary. The Knight Foundation will provide \$75,000.00 and the City of Gary will match with \$25,000.00. There are 14 applicants with proposals that will be reviewed before a decision is made.

- 6) The "State of the City Address" will be held on April 10, 2024.
- 7) Appreciation was expressed to the Gary Public Library and First AME Church for inviting the city administration to their Black History Month events. The City of Gary also hosted an event with Maryum Ali, daughter of world-renowned Boxer Muhammad Ali. She donated signed copies of her children's book "I Shook Up the World" to many students in the city of Gary.
- 8) Appreciation was expressed to Councilwoman Latham and her team who hosted a group of 8 black mayors from around the State of Indiana to discuss labor issues in their communities.
- 9) Appreciation was expressed to President Adkins for her annual "Senior Valentine's Brunch" held on February 24, 2024.
- 10) Councilman Halliburton was congratulated on his recent retirement of 25 years with the Indiana State Police.
- 11) The "Gary Air Show" will be held on August 17, 2024 thru August 18, 2024. Details are forthcoming.
- 12) Appreciation was expressed to everyone who attended the "United Negro College Fund Mayor's Breakfast" hosted at the Gary Career Center.
- 13) Mayor Melton requested that Dr. Janet Seabrook (Gary Health Commissioner) and Kianna Grant (Director of Constituent Services) be allowed to introduce themselves to the Common Council.
- Dr. Janet Seabrook (Gary Health Commissioner) introduced herself to the Common Council and spoke in regards of the goals of the Gary Health Department.

Kianna Grant (Director of Constituent Services) introduced herself to the Common Council and spoke in regards to improving and enhancing the 311 system.

Councilwoman Brown raised concerns to the administration in regards to the handicap accessibility at city hall.

Mayor Melton responded.

Councilman Washington expressed appreciation to the administration for their success in keeping Indiana Sugars located in the city of Gary.

Councilwoman Latham expressed appreciation to the administration for the demolition of the many structures in the Aetna community.

Mayor Melton responded.

Councilman Halliburton congratulated Andrea Roscoe for winning the Boys & Girls Club of Northwest Indiana's "2024 Youth of the Year" award.

President Adkins spoke in regards to updating the public on the status of the ARPA projects and the spending of the funds in the near future along with working with the Planning & Development committee on the status of new developments in the City of Gary.
